### **Award Description**

The Award has been inaugurated to honor Dr. Hoppel's service to Case Western Reserve University School of Medicine, and his outstanding career in mitochondrial biology as researcher, educator and mentor.

### **Presentation**

The award will be presented annually on the occasion of a special seminar delivered by the award winner at the CWRU School of Medicine in Cleveland, OH. The award consists of:

- An invitation to deliver the Charles L. Hoppel Award during the fall.
- A \$5,000 honorarium
- An engraved plaque
- Complimentary travel expenses for the winner and spouse to attend the Lecture and associated symposium / workshop

### **Nomination Criteria and Process**

- This annual international prize\* is to be awarded to a scientist who has demonstrated outstanding achievement in research in the broad field of mitochondrial biology. Independence of thought, originality of approach, clarity, and excellence of data presentation are important criteria. Originality, Impact and quality rather than number of contributions are to be emphasized. It is the responsibility of the nominator to make clear the contribution of the candidate to jointly authored articles.
- Of equal importance, the recipient will have demonstrated the professional commitment to academic medicine as teacher, mentor and in service to the community exemplified by Charles L. Hoppel, M.D. All scientists are eligible, but preference will be given to physician scientists.
- Selection will be made by the Awards Committee, comprised of accomplished mitochondrial researchers, other accomplished scientists and academic leaders, and benefactors of the Charles L. Hoppel, M.D. Endowment in Mitochondrial Biology.

### **Nomination Submission**

The nominations shall consist of:

1. A brief biographical summary of the candidate, including his/her research and academic credentials and contributions (in PDF and no more than 300 words).
2. A letter of nomination with a summary that describes the importance of the candidate's research work and contributions to academic medicine (in PDF and no more than 1000 words.)
3. The candidate's *curriculum vitae* and bibliography in PDF.
4. PDF files of six published articles, and/or manuscripts that have been accepted for publication, that are representative of the candidate's body of work in mitochondrial biology.
